11/10/05 Board Meeting Notes

(1) Board minutes approved from 10/13/05; (2) Reviewed October financials (see below); (3) Front building is winterized with water off and pipes drained, heat to be turned off; Scott will relocate canned goods being stored for Christmas Project to BASES storage room; (4) Trailer has been winterized and moved to its winter parking spot; (5) Decision approved to contract with BASES for \$100 per month for weekly detailed cleaning of back building; (6) Ap-

ple Fest fundraiser reviewed, deemed huge success, thanks to all volunteers; (7) 9 foot property issue has been resolved with corrected deed in hand; (8) Discussion of impact of City's new Historical District status on how this may impact future plans for dealing with property and buildings, Richard will pursue a meeting to gather more information with City Planner; (9) Reviewed and discussed host of options in relation to future plans with front building, need to get financial costs on each proposal, discussed timelines and plans to gather more input from general membership at December meeting (see back page); (10) Due to complaints from some attending meetings who are allergic to dogs and recent dog doo left on the floor, ALL DOGS ARE BANNED FROM

MEETING ROOM effective immediately; (11) Reviewed board election procedures, five board positions open at end of this year, all five outgoing board members interested in running again as well as an alternate who would like to become a full board member, additional nominees will be accepted until 6:00 pm Thursday, 11/17 by calling Scott (see back); (12) Tony volunteered to assist Sue in Oleson Slips counting and preparing; (13) December meeting to serve as public input opportunity on building ideas as well as serve as the annual meeting.
